

Texas Sheep and Goat Validation Checklist for Submitting Validation Materials

INITIALS ARE NOT ACCEPTED AS SIGNATURES.

- Validation Forms:** Verify **all copies** are clear and legible.
 - ❖ Please detach all pages and place all validation forms in alphabetical order by EXHIBITOR LAST NAME.
 - ❖ **Front (original) copy** – place in alphabetical order by LAST NAME, and secure in a separate stack for shipping
 - ❖ **2nd copy** – goes to Supervising AST or CEA
 - ❖ **3rd copy** – goes to County-Level State Sheep and Goat Validation Committee Chairperson
 - ❖ **Cardstock (back) copy** – place in alphabetical order by LAST NAME, and secure in separate stack for shipping
 - PAPER CLIP or BINDER CLIP the following to each exhibitor's Cardstock copy:**
 - ❖ **Nose Prints** – for market lambs, breeding sheep, and wether dams only
 - ❖ **DNA Hair Envelopes** – please make sure envelopes include ALL SIGNATURES
 - Note: Do NOT staple the DNA envelopes.**
 - ❖ **Registration Papers** – for registered breeding sheep and goats only

**Best practice is to make a copy for exhibitors/families.*

- Ethics Policy Forms:** Place in alphabetical order by EXHIBITOR LAST NAME, and secure in a separate stack for shipping (please submit **ORIGINAL** forms).
 - ❖ Verify **ONE** Ethics Policy form completed **PER EXHIBITOR**.
 - ❖ **ALL ETHICS POLICIES MUST HAVE A PHYSICAL ADDRESS!!**
- Parental Waiver/Hold Harmless Form:** Place behind exhibitor's corresponding Ethics Policy, **IF APPLICABLE!**
- County Validation Committee Form:** Must include a **MINIMUM** of **FOUR** members on the committee; complete and return with ALL members' **INFORMATION AND SIGNATURE**.
- Upload validation projects to the online validation website:** <https://www.texaslivestockvalidation.com/>
- Return unused hair sample envelopes and validation forms, free of markings.
- The County-Level State Sheep and Goat Validation Chairperson will send the original copy, cardstock copy, DNA envelopes, nose prints, and other validation paperwork **postmarked on or before November 8, 2022**, via priority/certified mail, return receipt requested to:

All forms and envelopes must be signed by the exhibitor(s), exhibitor's parent or guardian, the supervising Agricultural Science Teacher (AST) or County Extension Agent (CEA), and the County-Level State Sheep and Goat Validation Chairperson, even if the *Parental Waiver and Hold Harmless Agreement* is in effect. If the committee chairperson is the supervisor and/or parent/guardian of the exhibitor, another committee member will sign for the chairperson.
